

COMPETITION AND PRIZE DRAW RULES

Acceptance

I agree and undertake that I shall be bound by and comply with the terms and conditions for entry to the "e.tv ToyZone Easter Competition" ("the competition"). That in the event that I fail to comply with the terms and conditions of entry for any reason that my entry shall not be eligible and shall be disqualified from the Competition.

Terms and Conditions of Entry

1. In order to be able to enter the Competition and to be eligible to comply with the terms and conditions of entry, it is a condition that the person must be a resident of the Republic of South Africa.
2. Any person who is an employee of any of the following companies ToyZone (Pty) Ltd, e.tv (Pty) Ltd, eNCA (Pty) Ltd and/or any other agent, promoter and/or other person connected with the Competition and/or a member of their family shall not be allowed to enter the Competition and shall be ineligible to participate. If any such person should enter then they will be automatically disqualified.
3. e.tv shall be entitled at its sole discretion to declare that any entry is not to be entered for the Competition and is disqualified (whether or not the answer is correct.) In such event e.tv shall not be obliged to the person who has entered of their disqualification nor shall it be obliged to provide a reason for its decision.
4. All decisions of e.tv shall be final and e.tv (Pty) Ltd shall not enter into any correspondence, dialogue and/or otherwise with any person regarding any aspect of the Competition.
5. All entries must be original, and not abusive, defamatory, offensive, derogatory, degrading and/or otherwise not acceptable due to the nature of the material submitted.
6. e.tv (Pty) Ltd may at its sole discretion decide that any entry is not eligible due to the nature of the content of the entry and may disqualify a person from the Competition.

Prize(s) and Duration of Competition

18. By filling in all the details required in the entry form online in English and confirming your acceptance of the terms and condition of entry and submitting all the required details to e.tv (Pty) Ltd. No more than 10 entries will be accepted by the e.tv (Pty) Ltd from each person. All entries must be completed by the deadline. All persons who enter by this method must have the permission of the

person in whose name the computer is held and/or who pays the bill. An acknowledgement of entry will be provided by the e.tv (Pty) Ltd but no reference provided.

19. No responsibility can be accepted by the e.tv (Pty) Ltd for any entries which are lost, incomplete, are delayed beyond the deadlines, fail to arrive, are damaged, are illegible, inaudible, are not transmitted, do not arrive and/or for any other reason are not received by the deadline and/or are ineligible. Proof of posting is not accepted as proof of delivery.

20. No responsibility can be accepted by the e.tv (Pty) Ltd for the cost and/or charges incurred in respect of any entries. The e.tv (Pty) Ltd shall not be liable for any reason to any person who may enter the Competition and each person enters at their own risk and cost.

Prize Winners
